# Acquisitions of own ordinary shares of series A in Karnov Group

Karnov Group AB (publ) ("Karnov") has, during the period 7 April – 10 April 2026, acquired a total of 120,000 own ordinary shares of series A within the framework of the repurchase programmes introduced by the board of directors to optimise and improve the capital structure of Karnov by reducing the capital, thereby creating additional shareholder value.

The New Repurchase Programme, that was announced by Karnov on 25 March 2026, is carried out in accordance with the EU Market Abuse Regulation No 596/2014 and the Commission Delegated Regulation No 2016/1052. During the period 7 April – 10 April 2026, shares in Karnov have been acquired as set out below.

All acquisitions were carried out on Nasdaq Stockholm on behalf of Karnov by DNB Carnegie Investment Bank AB (publ) which makes its trading decisions concerning the timing of the purchases of ordinary shares of series A independently of Karnov. Following the above acquisitions, Karnov's holding of own shares as of 10 April 2026 amounted to 10,054,168 shares (whereof 9,828,266 ordinary shares of series A and 225,902 ordinary shares of series C). The total number of shares in Karnov amount to 108,102,047 shares (whereof 107,876,145 ordinary shares of series A and 225,902 ordinary shares of series C).
